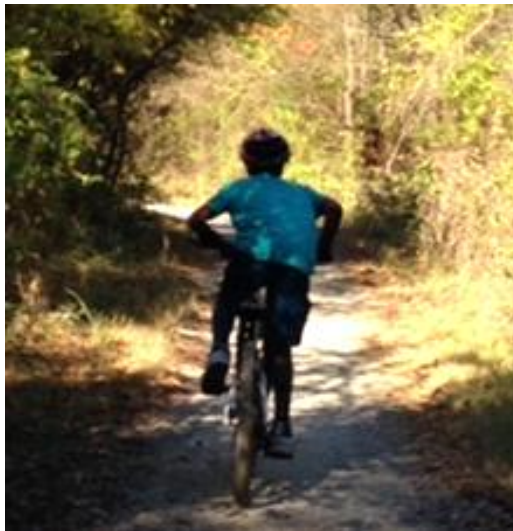

# Director's Letter

**The Children's Attention Home began as the vision** of three Rock Hill ministers who identified a local need for temporary housing and care for abused and neglected children. The vision quickly grew into reality as the larger community became aware of the need and took ownership of the idea. The community began to support by volunteering both time and financial resources, and before long, a house was rented. Live-in house parents were hired and the Home opened in November of 1970 as an emergency shelter with capacity for nine children.

The intent from the start centered on providing short-term housing, clothing and food for children desperately in need. Forty-six years later, as 2016 draws to a close and we anticipate the Home's future, we realize much has changed since those humble beginnings...

No longer does the Home occupy a single house; capacity is now at 42 children, ages birth to 21, housed in three separate cottages on a centralized campus.

We are no longer just an emergency shelter meeting basic needs. Lengths of stay have steadily increased, as have the various needs of the children we serve.

With the support, collaboration and coordination of numerous community volunteers and organizations, we work to prepare children for meeting the challenges of daily living. We focus on teaching them valuable life skills appropriate to each developmental stage, and support and encourage their physical well-being, emotional healing and educational success. **Our goals today include taking the steps we can to end the cycle of abuse with the generation of children currently in our care.**

**The scope of children and youth needing our services also continues to change.** Unfortunately, the need has continued to increase through the years. In addition to the children we serve through referrals from the South Carolina Department of Social Services, there are now identified needs for homeless youth, homeless refugee children, and teens rescued from sex-trafficking. Also, the Department of Social Services is exploring the decentralization of various services they currently provide to Level One group shelters. Each new population and/or service will require increasing levels of staff preparation and expertise.

In spite of all that has changed and evolved with time, the mission of the Children's Attention Home remains the same – **to provide a safe and nurturing home for abused and neglected children.** As we seek to diversify our services to meet the changing needs around us, that focus will remain at the heart of what we do.

# The Children We Serve

## SIBLING GROUPS

Here at the Home, we are able to serve sibling groups that the Department of Social Services has difficulty placing. Typically, about 50% of the children we serve are sibling groups.



Two years ago, Lacey\* and Talon\*, arrived at the Home. Lacey,\* quiet and shy, struggled to interact with those her own age. Talon\* came in with limited verbal communication, still on a bottle. Both children lacked social skills due to the neglect they had suffered.

Our team immediately began taking steps to set them on the right track. Lacey\* was placed in a local daycare, and Talon\* was weaned off the bottle in just a few days. Lacey\* was placed in a Headstart program to prepare for kindergarten, while Talon\* was placed in preschool. They continued to grow both individually and as a family.

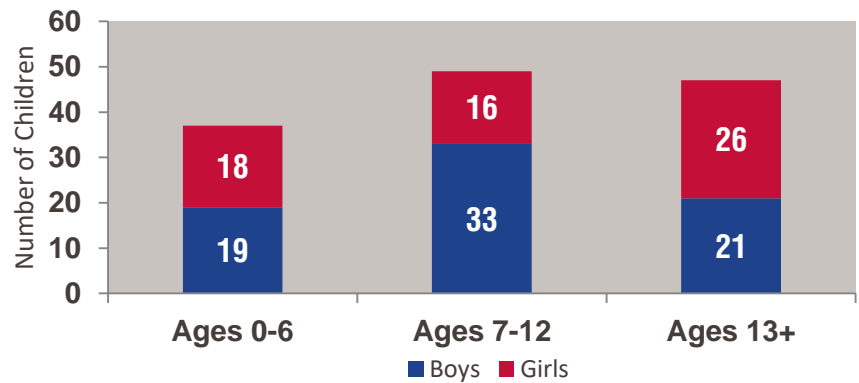
This August, Lacey\* started her first year of “big girl school”, and has blossomed into a social and happy young lady. Talon\* is able to recognize his alphabet, numbers up to 20, all of his primary colors, and is in the beginning stages of writing. They have made significant strides in every area of development, and they were able to do it together.

Through constant love and support, we’ve seen them grow and thrive as individuals, and at the same time grow together as brother and sister.

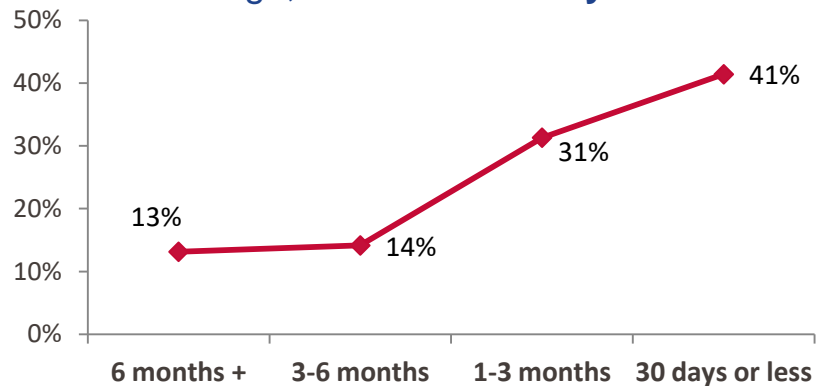

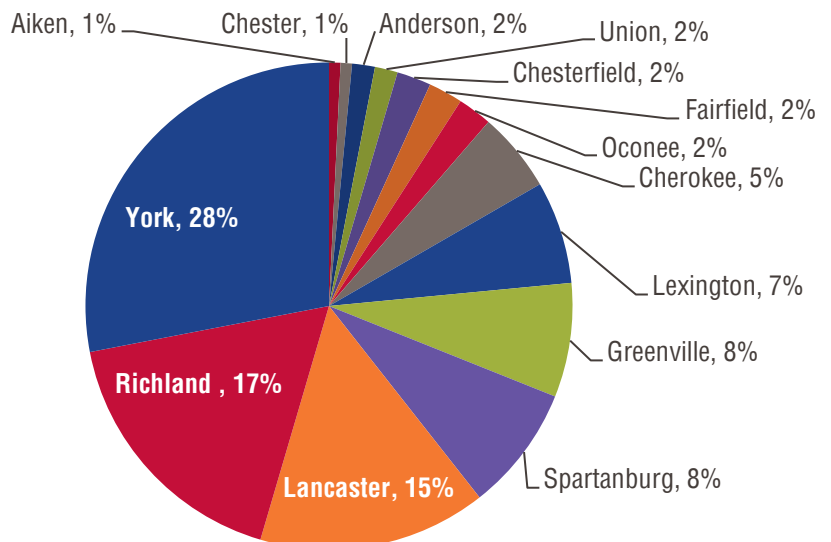

# Learning Healthy Living

The Social Work Program at the Children's Attention Home equips every child with the skills they need to be his or her best self. Through the teaching of life skills, coping skills, social skills, and independent living skills, children are positioned for future success regardless of where their lives take them.



## Social Work Groups

Age-appropriate Social Work Groups are held weekly and cover a variety of topics to help our children learn healthy living skills and prepare them for life beyond their time at the Home. Residential team members are also trained on what the children are learning in order to reinforce the skills throughout the day.

# Succeeding in the Classroom

School is an area of struggle for many of our children. We promote educational progress by encouraging a positive attitude about learning and equipping them with the tools they need to be successful in the classroom and beyond.



## Education Matters

As one of the greatest predictors of future success, academics play a vital role in the development of our children. This past March, we expanded our academic program to include an Education Coordinator to case manage our children's academics, provide assessments for all children when they enter our care, and coordinate tutoring resources for all residents.

Rebecca\* came to live at the Home nearly two years ago when she was 14 years old. When she arrived, she tended to follow in the footsteps of others and took a backseat to make others happy.

Despite this tendency, she also recognized right from wrong, and she sought to make the most of the opportunities she was given during her time living at the Home. Unlike many of our children who face significant setbacks in school, Rebecca\* excelled in school and made good grades. When given the opportunity, she requested tutoring to get ahead in her classes before starting high school this fall.

As a freshman this year, Rebecca\* has made the honor roll, while at the same time participates in color guard and band. During her time here at the Home, we have watched her blossom as a leader and develop into a confident young woman who is an example to other youth we serve.

# You Make Our Mission Possible

Our work would not be possible without the armies of volunteers, donors and supporters from our community. The Home was started by the community coming together to give these children a chance. Your efforts make it possible to continue providing hope for the future of every child we serve.

In this next year, we will face new challenges with the start of our homeless teen program.



We receive calls on a regular basis from children, or others on their behalf, who are simply looking for a safe place to sleep and basic needs to be met.

Across the country, the number of homeless teenagers is rising. In Rock Hill alone, approximately 100 teens were identified as homeless at the beginning of the school year. These children have not had a stable home or someone to give them a chance.

In addition to the children we currently serve who are in foster care, we will be providing these youth with love and attention, a safe place to live, and basic needs, as well as the resources and life skills to be successful beyond their time at the Home.

Unlike our children in foster care, we will receive no government assistance for these children. We are relying on the generosity of our community to provide the funding we need to care for these youth.

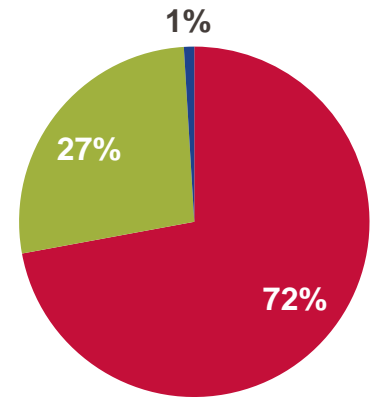

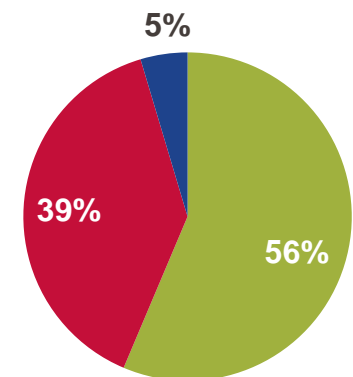
