RESIDENTIAL CARE IS CRITICAL TO MEETING THE CHILDREN'S EMERGENCY AND BASIC NEEDS INCLUDING FOOD, CLOTHING, SHELTER, AND HEALTHCARE. DEVELOPMENTAL SERVICES FOCUSES ON THE INDIVIDUAL NEEDS OF EACH CHILD INCLUDING SOCIAL DEVELOPMENT, EDUCATIONAL SUPPORT, CULTURAL ENRICHMENT, INDEPENDENT LIVING SKILLS, AND WORKFORCE PREPAREDNESS. DUE TO A SHORTAGE OF FOSTER HOMES, MANY YOUTH ARE SPENDING DAYS AND NIGHTS IN SOCIAL SERVICE OFFICES. INSTEAD, THIS DAYTIME PROGRAM ENSURES CHILDREN RECEIVE BASIC NEEDS, SUPPORT SERVICES, AND THE INDIVIDUALIZED ATTENTION THEY DESERVE WHILE WAITING FOR A HOME.
